- 5. MATTERS ARISING FROM LAST MEETING:

6. FOOTPATHS INCLUDING OLD HUNSTANTON PROJECT:

Discussions from the footpath meeting held on the 20 December:

Giving the Permissive Paths project a push in the New Year would be timely given the fact that the Neighbourhood Plan is going to referendum in the first quarter.

The NP, reflecting the wide support for access to more footpaths in the parish in the original consultation exercise, refers to the desire re 'Improving footpaths and walks within the village and parish, including circular walks and enhancing pedestrian access to Hunstanton along the A149 and to the adjacent villages, Holme-next-the -Sea and Ringstead.'

92 per cent of questionnaire respondents were in favour of more or better access to walking within and beyond the parish. Such a Permissive Path scheme would also help integrate the village and allow much easier pedestrian access between the old and newer part of the village.

The Permissive Paths we would like to see are inside the hedgerows from (i) Ringstead to Gypsy Corner on the east side of the road, (ii) Gypsy Corner to Holme on the south side of the A149, (iii) Gypsy Corner to Church Road on the south side of the A149 and (iv) the top of Church Walk to the Village Hall going north and then west inside the edge of the field

Ideally, we'd also like to see a fifth short permissive path from Peddars Way where it turns north after running west from the Holme to Ringstead Road, so as to continue west to the Ringstead to Old Hunstanton Road, thus creating a circular walk.

We will seek to have a dialogue with the tenant farmer of the relevant land, the ultimate landowner, and the owners of Courtyard Farm to find out how they manage and fund their permissive path network. We note the detail of the Norfolk Local Access Forum Parish Paths Scheme, supported by Norfolk County Council and the related information pack.

- **e.** Clerk had received an email from a resident "regarding the building site of the new home at the Wodehouse Road end of Hamilton is an absolute nightmare. Not just how many workers vans & lorries etc., are parked here all day but the state of the road itself. There is mud all over the pavement & road and no attempt to clean up before they leave. The pavement where tarmaced, has been broken up, meaning pedestrians now have to walk in the road. Having spoken to the builders it's clear that nothing will be done to rectify this in the near future".

Cllr de Winton advised "I suggest you email Planning Enforcement as there will be conditions attached to the Planning Consent regarding a Build Plan. If there are no conditions on the Planning Permission and the road is not County Council, there is not much we can do". Resident will speak to Enforcement and thanked the clerk.

- **f.** Grit bins on Church Road. Clerk contacted Highways regarding one of the 2 bins not being refilled this year. Highways advised that only one bin was their responsibility. SR confirmed that this particular bin is nothing to do with the Church and that the council used to fill it in the past. Clerk to go back to Highways.

- **g.** Cycle Storage offer there is only one per parish and we would need exact location with a base to put it forward. Village Hall or Playground location to be decided.

- i. A new defibrillator has had to be ordered.
