MINUTES OF THE PARISH COUNCIL MEETING OF OLD HUNSTANTON PARISH COUNCIL HELD ON THURSDAY 18TH of JULY 2024 FROM 6.00PM AT THE VILLAGE HALL

1. WELCOME TO ALL FROM THE CHAIR

2. PUBLIC PARTICIPATION – Questions on why the parking cones had been removed – see item 6a

3. APOLOGIES FOR ABSENCE – Cllrs Jamieson, J Rimmer, S Rimmer, S Perry. Clerk

4. COUNCILLORS DECLARATIONS OF INTEREST – None

5. APPROVAL OF THE CIRCULATED MINUTES FROM THE MEETING ON THE 20th of JUNE proposed NE, seconded MR and all in favour who attended.

6. MATTERS ARISING FROM LAST MEETING:

- a. TRO / Cones parking update – It was confirmed that Damien Jeffries at NCC Highways had instructed his onsite visiting inspector to remove the cones from Wodehouse and Hamilton Roads. It was explained that this was not in line with the practice over the past three summers (NCC Highways authorised) or the draft TRO plan which NCC Highways presented to the public at the Village Hall.
It appears that the complaint of one resident to a director at NCC last August had occasioned this change of policy. Villagers who wish to complain this summer about parking issues on roads where there are no cones, were advised to make complaints directly to NCC Highways and the Police. The Parish Clerk has already received more than 20 complaints since the cones were removed.
In response to a question, the Chair said he had no reason to believe the approved TRO plan would be amended or that it would not be implemented in time for the 2025 season, but he would follow up with Cllr Andrew Jamieson, Deputy Chair at NCC, to seek his support in getting the timetable confirmed.
- b. Parking by the Le Strange Hotel – The parish council have replied to a letter from the hotel's solicitors. In the meantime, the hotel has removed the ropes cordoning off the area.
- c. Rubbish on playing field – Letter has been sent to the football club but no reply to date. It was agreed to follow up once the football season starts, if parking along Church Road persists.

7. FOOTPATHS INCLUDING OLD HUNSTANTON PROJECT:

Post the consultation re the Neighbourhood Plan, villagers had identified more walking options as a priority. The potential permissive paths, identified by the sub-committee, that would provide more, and better local walking options are on land owned or leased by Mr. Pull. The Parish Council will write to Mr. Pull to ask him to engage to discuss potential permissive paths. The Parish Council believes funding is available so not cost to be borne by the landowner. The Parish Council will report back to the village at the next meeting.

14. AONB/NORFOLK WILDLIFE TRUST/HERITAGE ENGLAND/ENVIRONMENTAL:

NE urged all to view on YouTube, the short documentary presented by John Madden on the history and development of the nature reserves in Lingfield, Surrey. It was noted that both Holme and Thornham now have nature reserves and one in Old Hunstanton would be most desirable. The field south of the A149, East of Church Road, was mentioned as a potential site (leased by Mr. Pull) but NE noted that before even trying to identify a site we would need to find volunteers in the village who would be prepared to take it on as a project. The Parish Clerk to include this on the website, seeking villager interest and in the newsletter.
