1. WELCOME BY THE CHAIRMAN

Cllr. Mcleod welcomed everyone to the meeting.

11. PLANNING APPLICATIONS

Resolved. (Unanimous). Old Hunstanton Parish Council have 'no observations'

12. NEIGHBOURHOOD PLAN

The N.P. Admin Assistant reported that the B.C.K.L.W.N. has to assess whether the N.P. requires a Strategic Environmental Assessment (SEA) and a Habitats Regulations Assessment (HRA) as required by European Directives. The B.C.K.L.W.N. need to consult with the Environment Authority, Natural England and Historic England. The process takes six weeks so the P.C. will have a decision by the end of February.

With reference to the 'Green Spaces' there had not been a reply from the Le Strange Estate.

N.D.H.A's - Stephen King had approved all except for one property.

The N.P. Admin Assistant also reported that the B.C.K.L.W.N. would like to extend the Conservation Area in Old Hunstanton and Mr. King was interested to get the general opinion of O.H.P.C. to the idea. The matter was discussed noting the following comments:-

This should be put into the Neighbourhood Plan

More Conservation Area would be likely to provide more protection against development

The Pepperpot Houses locations were important in this matter.

Resolved. (Unanimous). That the Parish Council would be pleased to have the whole of Old Hunstanton in a Conservation Area but that the P.C. would support any suggestions from Mr. King.

13. FOOTPATHS NETWORK IN OLD HUNSTANTON PROJECT

Cllr. Eastwell reported from his meeting with Mr. Meakin where they discussed the desire to create permissive footpaths from Gypsy Corner east along to Holme and south to Ringstead. Mr. Meakin was sympathetic but noted that Rural Payments Agency Schemes, in the next couple of years, were likely to fund carbon capture, conservation and enhanced public access to land rather than food production. Mr Meakin noted that farmers may fear that providing additional public access, ahead of such schemes, may act to their detriment in the longer run. Mr Meakin had stressed that this should not stop the debate. Cllr. Eastwell also noted that a cost would be involved and a discussion about a contribution would be needed.

In addition Mr. Meakin advised that the beach signs had been changed to urge visitors to take their rubbish home. Cllr. Eastwell concluded that it had been a very positive meeting and that he had shown Mr. Meakin the draft Neighbourhhood Plan. Mr. Meakin would like to attend a Parish Council meeting once a year when the meetings start to be held in person.

There were no updates on the widening of the footpath between Lighthouse Lane and Golf Course Road. There were no updates from the Footpath Working Party.

14. HIGHWAY MATTERS. PARKING AND SPEEDING ISSUES

PARKING

The matter of a T.R.O. application to prevent the parking problems was discussed. There is already some seasonal signage to stop parking by visitors but this needs to be extended, possibly with the addition of single yellow lines. The question of which roads to include was considered and the result was to apply for 'No parking' signage and yellow lines for the season from Easter to the end of September on all roads north of the A149.. SPEED SIGNS

These were to be requested on the T.R.O. as previously discussed.

Resolved. (Unanimous). That the Parish Council wish to apply for T.R.O.'s to have signage and yellow lines on all roads north of the A149, the 30mph speed limit sign moved from the corner of Church Road/A149 to the east side of the bridge and to have a 20mph speed limit starting at Church Road/A149 junction all through the village to include Church Road and Chapel Bank. The Clerk would start with advising Highways of these provisions for consultation with County Hall.

15. SAXON SHORE FORUM

The Minutes of the Saxon Shore Forum of 3rd December 2020 had been forwarded to all Councillors. The only matter raised was by Cllr. Torry who noted that, contrary to a report on page 3, he had not installed a fence – this had been done by the Golf Club. The Clerk would advise the Clerk of the meeting.

16. A.O.N.B.

- a. The Clerk advised that the letter to James Wild MP had not had a reply yet.
- b. It was noted that Clive Doarks had been unable to attend the January meeting so the Clerk would suggest March or April to Mr. Doarks.
- c. There were no further updates from Cllr. Torry.

17. ENVIRONMENT PANEL

There were no updates for this agenda item.

18. RUBBISH BINS AND DOG BINS AT O.H. BEACH

19. WALL RE-BUILDING IN OLD HUNSTANTON

The Clerk had forwarded the latest response to Cllrs. The response stated that 'the majority of the wall is within permitted development' and that no further action would be taken. Cllr. Eastwell would check the legislation.

The Clerk agreed to contact the Police and request their assistance in this matter.
